

COMMUNITY ELECTRIC COOPERATIVE

**Schedule B - General Service**

**AVAILABILITY**

Available throughout the Cooperative's service territory to general service consumers subject to the Cooperative's Terms and Conditions of Service.

**APPLICABILITY**

This Schedule is applicable to any consumer purchasing alternating current electricity for all uses including lighting, heating and power up to 50 KW demand.

**TYPE OF SERVICE**

Single phase, and three phase where available, 60 cycle, at the Cooperative's standard voltage.

**MONTHLY RATE**

- I. Distribution Facilities Charges
  - A. Base Facilities Charge:
    - \$27.89 per month for single phase service
    - \$31.52 per month for three phase service
  - B. Energy Delivery Charges:
    - All KWH delivered @ \$0.01235 per KWH
- II. Plus Generation and Transmission Supply Charges:
  - All KWH @ \$0.04624 per KWH

Note: The above Delivery Service and Energy Supply Service charges apply to those Customers who have the Cooperative as their energy service provider. Only the Distribution Delivery Service charges apply to those Customers who have an Electricity Supplier, other than the Cooperative, as their energy service provider.

**MINIMUM MONTHLY DISTRIBUTION DELIVERY CHARGE**

The minimum monthly charge applicable to Part I of the foregoing monthly rate shall be the Base Facilities Charge where 25 KVA or less of transformer capacity is required. For consumers requiring more than 25 KVA of transformer capacity, the minimum monthly charge Applicable to Part I shall be increased by \$0.75 for each additional KVA or fraction thereof required.

**MINIMUM ANNUAL CHARGE FOR SEASONAL SERVICE**

Consumers requiring seasonal service shall remit a minimum annual payment of twelve (12) times the minimum monthly charge determined in accordance with the foregoing section. During each billing month that the service is connected, the account shall be credited with one twelfth (1/12) of the minimum annual payment and charges shall be

levied in accordance with the foregoing sections. Only in the aforementioned manner shall any portion of the minimum annual charge be refunded or credited to any account. Extensions of facilities for seasonal purposes shall be made in accordance with Section XIV of the "Terms and Conditions of Service."

**TEMPORARY SERVICE**

Temporary service shall be supplied under the foregoing rate and made available in accordance with Section VI of the "Terms and Conditions of Service." The Cooperative may require a deposit, in advance, of the full amount of the estimated bill for service, including the cost of connection and disconnection.

**POWER COST ADJUSTMENT RIDER**

The amount of generation and transmission supply charges calculated under Part II of the Monthly Rate is subject to increase or decrease pursuant to the provisions of the Cooperative's Power Cost Adjustment Rider, Schedule PCA-1.

**TERM OF CONTRACT**

The term of contract is to be not less than twelve (12) months.
